Annex I: Updates provided to the SC members during the meetings held.

Re: Updates on the Seychelles MSP initiative June 2015 to Feb 2016.

Following the last round of consultations in June 2015, ongoing revisions of zoning design 2.0 and development of the marine plan, the MSP core team would like to provide an update on progress that has been made to date for your information.

Updates on the Seychelles MSP

- The legislative and policy review by Ms Iris Carolus was approved by the Steering Committee via email and finalised 30 Nov 2015. The report has been shared with the consultants that are revising the PA Bill and regulations for their reference and identification of gaps pertaining to the MSP. The report will not be posted for the public but will be available for other relevant projects.
- The MSP logo was endorsed officially by government and is being used on the letterhead and also for the MSP office window located at Eden Plaza (on the first floor, opposite the SPAR management office).
- There has been a delay in the initiation of the Socio-economic impact analysis as TNC was trying to synergise their efforts with the negotiations for the debt swap and European Investment Bank. TNC



has determined that the needs for EIB are different from the MSP and thus will proceed with a limited scope socio-economic impact assessment for fisheries and tourism sectors.

- Following June 2015, the MSP core team adopted a one to one approach to stakeholder consultations to further refine the zoning design 2.0 and develop a marine plan. Refinements were made following discussions include;
 - All waters within the territorial sea (12nm from the HWM) are categorised as interim zone 2, except where existing marine protected areas exist. The 12 NM boundary contains several high use areas and high biodiversity values and final zone designation will need to be discussed per island group. Also, the MSP is awaiting information from the MSP Outer Island Projectd and the SFA Demersal Fisheries Management Plan for Mahe Plateau. Further refinements within the interim zone 2, including areas for Zone 1, will be made in Phase 2 of the MSP initiative which is 2017-2020.
 - The Northern Drop-off of the Mahe plateau now includes areas 2c and 2d as zone 1 with the higher use 2a and 2b as zone 2.
 - The South and South West drop off of Mahe Plateau of area 3 now zoned as areas 3a and 3b zone 2 and area 3c zone 1.
 - The latest version of the zoning design in 2.2 (Sept 2015).
- Milestones for the MSP process up to the year 2020 have been agreed to by MEECC and TNC, and reflect discussions with stakeholders from April June 2015. The milestones were necessary for the Debt Swap loan agreement and include a phased approach for refining the Interim Zone 2 areas and proposing locations for Zone 1. *Show milestones chart.*
- The Debt Swap deal has been finalised in COP21 with signatures scheduled end of Feb 2016.
- The SEYCCAT board was operationalized through its first meeting on 19th November 2015.
 - Composition of the board
 - Grants committee being finalised.
- An ad hoc MSP working group was formed in the fall 2015, and comprises mostly of representatives from the fisheries sector (industrial, semi-industrial and sport) TNC team is consulting with them to understand their concerns and receive their recommendations for revising the zoning design and allowable uses table.
- An ecosystem services study has been initiated with Natural Capital Project, for recreational and tourism values. Data and information may need to be gathered from the tourism sector if not available on-line or via Ministries. This project will run from Feb to June 2016.
- The MSP PM is engaging in other meetings to allow synergies with the MSP. These include but are not limited to the;
 - GoS-UNDP-GEF Outer Islands Project, PA Finance projects
 - PA legislative review (Bill & Regulations)
 - BioFin
 - SWIOFISH3
 - GEF6 PIF formulation
 - WIOMER
 - Demersal fisheries management plan of the Mahe Plateau
 - Blue Economy initiative



- Dr Joanna Smith has given a few presentations on the MSP Initiative and methodology the zoning design has not been shared. At the 9th WIOMSA held in SA in October 2015, Ecosystem Services Partnership in Nov 2015, and Pacific Seabird Group Feb 2016.
- The information packet on the MSP is being finalised.
- A short video on the MSP is being produced by a consultant through ICS and should be finalised by Q2 2016.
- The Project Manager attended a Project management and Budgeting training in Kenya in January 2016.

Next steps:

- 1) PM to carry out one to one meetings per sector to discuss further refinements of the MSP zoning design, address concerns and document proposals for implementation. Invitations to be sent to SC and TWG members.
- 2) The implementation plan is being drafted. It will need to be endorsed by stakeholders.
- 3) Series of stakeholder workshops for final approval scheduled in Q3 and Q4 of 2016.

Outstanding issues:

- 1) Definition of Sustainable use, in particular for Zone 2.
- 2) Feedback on activities table for Zone 1 and Zone 2
- 3) Proposals on governance of the MSP for implementation
- 4) Proposals on Control, monitoring and surveillance
- 5) Feedback/suggestions on sustainable use area management Which legislation to use and which Ministry?
