Area 1 Mahé Plateau	Need to determine what activities will be	J.S.
	allowed in the BD zones on the plateau.	
Area 1 Mahé Plateau	Need to differentiate between Petroleum	J.S.
	and BD/Fisheries. Petroleum is a 'potential'	
	activity whilst BD conservation and	
	fisheries are existing pressures and these	
	need to be addressed differently. In this	
	case Petroleum should be given a lower	
	objective.

Area 1 Mahé Plateau	Need to consider phases of oil exploration and Seychelles is currently in an active exploration state.	James Mougal responded by suggesting to go ahead with zoning for plateau without petroleum included but once petroleum activities are determined these can be re-zoned.
Area 1 Mahé Plateau	On the Mahé plateau tourism is essentially 'fisheries' as most tourism activities here is in the form of fishing charter and game fishing.	
Area 1 Mahé Plateau	Most other tourism activities are within 10km of the coastlines.	
Area 1 Mahé Plateau	There are many other tourism activities to consider other than fishing such as yachting/boat charters.	
Area 1 Mahé Plateau	Fisheries and tourism in this area is accepted as essentially the same (big game fishing) and the activity goes to the edge of the plateau.	
Area 1 Mahé Plateau	As has been raised in previous meetings, main concern with the scenarios is the feasibility of administering/managing many small polygons of BD protection areas.	J.S. to follow up
Area 1 Mahé Plateau	Agree on the management of many small PA issue. Also most conflicts arise with fisheries and BD priority areas particularly IBAs and this needs to be addressed.	
Area 1 Mahé Plateau	No preferred zoning option for Area 1.
