# Annex III: Workshop note on the scope of operation of the Authority. Provided for the working group

# sessions.

On the 4<sup>th</sup> of July 2018, the Cabinet of Ministers unanimously approved a decision to create an independent Marine Spatial Plan (MSP) Authority. This was the preferred stakeholder option put forward from a national consultation on the development of a governance mechanism for Seychelles' MSP. Cabinet furthermore sought:

- A fully and explicitly elaborated mandate of the proposed Authority, for their future consideration.
- Additional guidance as to what other functions such an Authority might logically and advisedly assume.

An elaborated draft mandate, based on the approved mechanism, is set out below. It includes the agreed roles of the primary bodies of the Authority i.e. the Board of Directors (Executive Committee), Secretariat, Management and Scientific committees.

Following that there are some additional bullet points for consideration pertaining to how the mandate may be expanded. Workshop attendees are invited to consider these but also to propose other areas that might logically fall under the auspices of the Authority, particularly areas where there is currently no clearly mandated agency.

# Mandate of the MSP Authority

Administration, coordination, oversight, monitoring and evaluation, review and adaptive management of the Seychelles Marine Spatial Plan, including:

- Governance of spatial planning the MSP/Oceans Authority Act (OAA) will explicitly devolve the power of marine spatial planning to the Authority.
- Monitoring, evaluation and periodic (every 5 years?) consultative revision of the MSP.
- Holding regular meetings of the Board to guide the strategic implementation of the MSP.
- Holding regular meetings of the management and scientific committees respectively.
- Ensuring pertinent international obligations are appropriately incorporated into the MSP management cycle and reported upon as required.
- Giving guidance to and ensuring compliance from MSP implementation agencies the OAA will require agencies to implement, cooperate as necessary and report on MSP implementation as per the OAA, MSP and its schedules and formats.
- Oversee the practical issues of Zone and PA management in line with their designation, including the establishment of parameters and criteria for MSP development management – e.g. allowable activities for each zone and the process for submission and approval of development/activity applications.
- Oversight, coordination and, where appropriate, implementation of:
  - Development of standard formats for PA management plans and reporting.
  - Development and review of PA draft management plans with clear measures to support area and MSP objectives.
  - Realisation of efficiencies, synergies and optimal use of capacities.
  - Monitoring of management plan implementation.
- Develop MSP scientific practices:
  - Identify data requirements to support MSP and crosscutting Area management plan objectives.
  - o Identify data requirements to support priority, area-specific management objectives.
  - Establish criteria for MSP datasets to facilitate analysis and utility.

- Undertake independent peer review of all datasets
- Identify strategic, crosscutting and key knowledge and data gaps for MSP management (Prioritised research agenda).
- Develop prioritised management-oriented research agenda.
- Develop and review model data sharing agreement(s)
- Identify, inform stakeholders of and pursue, as appropriate, funding options and mechanisms to support the sustainable implementation of the MSP.
- Public education, stakeholder communication and outreach.

Additional portfolio options for consideration:

- Areas beyond national jurisdiction:
  - Negotiation of high seas agreements etc.
  - Negotiation of EEZ boundaries
- National oversight of the Seychelles-Mauritius Joint Management Area.
- Oceanography in addition to the management of marine ecology (already addressed), also incorporate the other branches of oceanography, namely: physical oceanography, chemical oceanography and marine geology (including mineral exploration).

## Annex IV: Group 1 notes;

- a) SOA & MSP Timeline: Must take into consideration timeline for submission of Government budget i.e. start of process in February 2019 to meet the 2020 deadline. There are a number of challenges which need to be promptly addressed if timeline kept as recommended i.e. backlogs at AG's office and National Assembly + National Assembly process for submission of legislation, the election scheduled for 2020-everything stalls in Seychelles one year prior to the elections.
- b) Mandate of SoA: we can already see a number of overlaps between mandate of MSP and those of already established authorities. There is a need for all parties concerned to sit down together and have a candid discussion about how they would need to work with the SoA. The mandates of established departments/authorities need to be mapped out and consensus found on the roles/responsibilities of SoA. What will happen to the Blue Economy Department? There is already a duplication of roles. This review needs to be factored in above-mentioned timeline. The issue of enforcement and surveillance of protected areas is today a very serious weakness. This needs to be addressed either in terms of the role of the SoA or a clear decision taken as to which entity will be responsible for it. This will involve additional budget/human resources across the board.

It is mentioned in the proposed mandate that SoA will "undertake independent peer review of all datasets"precision needed i.e. datasets for protected areas only.

In terms of the suggestion made for SoA to be responsible for negotiation of high seas agreements and negotiation of EEZ boundaries, there is consensus that this is needed but SoA cannot play the leading role. It can be part of the team overseeing JMA for example as the latter has its own governance structure made up of several stakeholders and no one entity supersedes the other.

Agreed that oceanography should be included but one person made the proposal that oil/gas should also be part of the list provided.

Seychelles Ocean Authority & MSP timeline

Integrate authority power into /the VETO power will allow to override existing mandates

### Comments to Mandate of the MSP Authority

Point2- a process that may begin 1 year earlier for first rotation, or less duration for beginning (mid-term review in-between?)

MSP authority will simply oversea existing authority which will run under their own acts.

Point3- law will specify how often(scheduling) should meeting be

Point5- support government in international relations, already in their mandate. include national obligations? e.g. seabed mining as an issue.

Point6- flagged as an issue, need consideration on how to draft act; can we force another authority to comply? If under the president office may be the case. Change to 'promote compliance'?

Point7- VETO for oceans authority does it require amendment to both ACTS? It should sit on EPA & PA acts,

Point9- 'identify data requirements.' that may very well need you will need other specialised staff or ability to outsource.

### Feedback to portfolio options for consideration

Point1- Recognise that there are synergies with existing agencies... blue economy, how do they cooperate? Provide 'technical support' for agencies already occupying these negotiating role? This point may need to be discussed between PS BE, Environment & VP It should be recorded that the blue economy requested that its present management will need to be consulted.

Point3-the role of NISTI, SBS. especially in permits for oceanography how will ocean authority relate. Oversite of PSSA particularly on sensitive sea areas.

Ocean authority can become the competent authority for seabed exploration and extraction. Need to add 'Excluding petroleum and natural gas'

Point4- e.g. support fishing rights fees as means for revenue generation for Ocean Authority

Discussed-Climate change issues will need to be considered whether it twill be with this authority or underlying agencies.
