

MILESTONES

The MSP began in 2014 and has three Milestones, each for a percentage target for new marine protections in Seychelles waters. Implementation begins in 2021

MILESTONE 2 was gazetted on 12 April 2019 by Ministry of Environment, Energy and Climate Change (MEECC) for 26% in new marine protection areas - 350,915 square kilometres.

MILESTONE 3 began in March 2019 for the remaining 4% target of marine protection areas. More than 50 workshops, consultations and meetings were held in March-April, July and October to propose and discuss new marine protection areas. With support from stakeholders, the MEECC and the MSP core team presented to the Cabinet of Ministers in October 2019 for approval to nominate 13 areas for protection status. The request was approved and a nomination file was submitted to MEECC in December 2019. The notice of intent to gazette the areas was published in January 2020 and 28-day public review period will follow as per the Act (NPNCA).

MARINE SPATIAL PLAN

The Seychelles Marine Spatial Plan has three zone categories including **Zone 3 - Multiple Use** areas. Discussions for management of Zone 3 will take place in 2020 including addressing **climate change adaptation** and supporting the **Blue Economy Roadmap** throughout all Seychelles' waters.

Allowable activities, management considerations, and other aspects for management of the MSP zones are underway, to completed Dec 2020.

CLIMATE CHANGE

NDC. MEECC, SeyCCAT, PEW and TNC are advancing work on **Nationally Determined Contributions** in support of Seychelles' climate strategy. The SMSP is assisting with data for seagrass, mangroves and coral reefs.

BLUE ECONOMY

Sustainable fishing. With Seychelles Fishing Authority and The Nature Conservancy's Indo-Pacific Tuna team, a pilot Electronic- Monitoring (EM) project is underway with the industrial longline and purse seine tuna fleet. Six vessels will install video equipment and protocols for data review are being developed.

A FAD and E-monitoring workshop

co-hosted by Ministry Fisheries and Agriculture, Seychelles Fishing Authority, and The Nature Conservancy will be held in March of 2020 with representatives from the Industrial fisheries sector to discuss draft criteria for sustainable fishing for the implementation of the MSP.

The MSP core team has provided input to the **Blue Economy Action Plan** to ensure synergies with the marine plan.

IMPLEMENTATION PLAN

Financing. A SMSP, SeyCCAT and GoS-UNDP-GEF PA Finance Project developed three scenarios for implementation of protection areas including costing and sources of financing. Three stakeholder workshops were held and a final report submitted to MEECC.

Governance Arrangements. The

research for the concept of an independent ocean authority is underway including financial requirements and capacity needs. In Oct 2019 the cabinet of ministers approved for the development of a full framework for the Authority to proceed towards operationalization.

Policy. A draft MSP Policy is necessary for implementation of the MSP and is undergoing international peer-review. Stakeholders will be consulted for any revisions before finalisation and presentation to Cabinet.
